

AFFIDAVIT

(To be executed on Rs.10/- Non-judicial Stamp Paper duly attested by a First Class Magistrate or Notary Public)

I, _____ D/S/o _____ aged _____ years R/o _____ do hereby solemnly affirm and declare as under:-

1. That my son/daughter Mr./Ms. _____ has applied and has been offered admission at Naraini Educational and Charitable Society's Group of Institutions (NGI), 8th Milestone, VPO Chirao, Assandh Road, Karnal – 132036, Haryana.

2. That I have read and understood the rules and regulations of the Institute and I am executing this Undertaking/Declaration on my own free will and consent along with my son/daughter without any force, fraud or coercion. I and my son/daughter shall abide by the undertaking/declaration and the rules and regulations of Institute failing which the Institute shall be free to take such action as it may deem fit including cancellation of his/her admission.

3. That I have clearly understood the refund and cancellation policy of the Institute and the financial impact of a mid-course withdrawal from an unaided self financed institution like Naraini Educational and Charitable Society's Group of Institutions (NGI). Therefore, in the event my child withdraws his/her admission after the cutoff date subsequently admission or mid-course before the completion of the course, I undertake to pay the balance years tuition and development fee since the seat cannot be filled by the Institute, I am aware that the Institute is entitled to claim the said amount in view of the Constitution Bench Judgment of the Hon'ble Supreme Court of India in the case titled "Islamic Academy of Education Vs. State of Karnatka" bearing CWP No. 350 of 1993.

4. That I undertake to pay the Institute the Tuition and Development Fee as stated herein above on the basis of a written demand made by the Institute at my aforesaid address and the same shall be a conclusive proof of the seat remaining unfilled at the Institute after the withdrawal of admission by my child.

5. That the demand for the balance year's tuition and development fee by the Institute shall be final and acceptable to me and I undertake not to question the same and undertake to pay the same within the period as stated in the demand letter. In case I fail to do so, besides withholding my no dues clearance/migration/character certificate, the Institute shall be entitled to take legal recourse to recover the same at my risk and peril as to costs and consequences.

6. That the contents of this affidavit have been read over and explained to me in vernacular and I am executing the same after understanding the contents thereof.

7. That the admission of my son/daughter is Provisional subject to confirmation/approval by the Affiliating University/SBTE/HSCS. If admission is not approved by the Affiliating University/SBTE/HSCS, I and my son/daughter will have no claim for admission to the Institute.
